EXECUTIVE SUMMARY

This report provides information regarding the State Office of Primary Care and Rural Health (SOPC-RH) efforts to address critical health care workforce shortages in underserved areas of Kansas during 2022. Rural health care access has long been a challenge in the state due to its vast geographical landscape and population distribution. These disparities were made even more apparent with the onset of the COVID-19 Public Health Emergency.

Despite commendable efforts to augment the health care workforce, enduring factors contributing to shortages, coupled with a wave of resignations nationwide triggered by the COVID-19 pandemic, have perpetuated the uneven distribution of essential health care professionals across Kansas. Even under the Public Health Emergency declaration, these disparities continued to widen, making underservice and a shortage of professionals a particular hardship in the state.

The SOPC-RH administers a suite of programs designed to address these challenges. Through state and federal scholarships, loan repayment initiatives, and federal agency sponsorship of international medical graduates, we aim to directly address the immediate needs of our communities. Moreover, programs offered directly by federal agencies include payment enhancements for rural health clinics and Medicare bonus payments designed to ensure the financial viability of health care practice sites in rural communities.

All programs administered by the SOPC-RH adhere to a consistent set of eligibility requirements. A service area, often a county, must meet specific criteria to attain designations such as Health Professional Shortage Area or Medically Underserved Area. The first half of this report is dedicated to defining the various health care shortage designations and the efforts taken by the SOPC-RH to mitigate these shortages. The second half of this report provides comprehensive information, including but not limited to health care facilities, program awards, and shortage designations for all 105 counties in Kansas.

Health Professional Shortage Areas

A Health Professional Shortage Area (HPSA) is a designation that indicates an area that lacks sufficient health care professionals in primary care, dental or mental health to meet the health care needs of the population. These areas can be a group of counties, a single or partial county, or a facility. More than 30 federal programs use HPSA designations to identify areas of greater need and allot resources accordingly. A few of the programs that use HPSA designations include:

- National Health Service Corps (NHSC)
 - NHSC Practice Sites
 - Loan Repayment Program (NHSC LRP)
 - Students-to-Service
 - Nurse Corps Loan Repayment
 - Nurse Corps Scholarship Program
 - Rural Community Loan Repayment
 - Substance Use Disorder Workforce Loan Repayment
- Centers for Medicare and Medicaid Services (CMS)
 - Medicare Incentive Payment
 - o Rural Health Clinic Program
- Conrad 30 J-1 Visa Waiver Program
- Special consideration and funding priority for Area Health Education Centers (AHEC)
- Kansas State Loan Repayment Program (SLRP)

Each HPSA designation is assigned a numeric score from zero to 25 for primary care and mental health, and zero to 26 for dental health, based on population health care needs and access to health care professionals. For some programs, such as the NHSC LRP, which provides educational loan repayment to health care professionals in the highest areas of need in each state, the score is taken into consideration as part of the eligibility criteria for participation. To obtain a HPSA designation, the area must:

- Be a rational area a partial, single, or group of counties – for the delivery of health care services.
- Have a specific population-to-professional ratio.
- Demonstrate that health care professionals in contiguous areas are excessively distant, over-used, or inaccessible to the population under consideration.

Types of HPSA Designations

There are different types of HPSA determinations, the most common being Geographic HPSA and Low-Income Population HPSA, as described below.

Geographic HPSA

Geographic HPSAs allow health care professionals to participate in the Physician Bonus Program, which pays a 10 percent bonus for outpatient services for Medicare beneficiaries. Primary Care Geographic HPSA designations in Kansas are calculated using the ratio of a county's population compared to the number of full-time equivalent (FTE) professionals providing direct patient care services in that county. Each professional's direct patient care hours are compiled to calculate the FTE; 40 direct patient care hours per week equals one FTE. The minimum population-to-professional ratio for a Primary Care Geographic HPSA is 3,500:1.

Population HPSA

Population HPSAs reflect the health care needs of specific populations to determine if the area qualifies as a Low-Income Population HPSA or Medicaid-Eligible Population HPSA. More than 30 percent of the area's population must be under 200 percent of the federal poverty level (FPL) to qualify for a Low-Income Population HPSA or a Medicaid-Eligible Population HPSA.

Indian Health Facilities, Other Facility HPSA and Auto-Facility HPSA

Other Facility HPSAs and Auto-Facility HPSAs reflect the specific health care needs of populations served by a correctional facility, county or state mental hospital, and public or non-profit medical facility. Federally qualified health centers (FQHCs), rural health clinics (RHCs) and Indian Health Service clinics are eligible for Auto-Facility HPSA designations. Scores for Indian Health Facilities/Native American Tribal Population HPSAs and Auto-Facility HPSA designations are calculated by the Shortage Designation Branch of the Health Resources and Services Administration (HRSA).

Direct patient care hours delivered by the following professions are considered when calculating Geographic and Population HPSA ratios.

Primary Care

- Doctor of Medicine (MD) and Doctor of Osteopathic Medicine (DO)
 - Family Practice
 - o Internal Medicine
 - Obstetrics and Gynecology
 - Pediatrics

Dental Health

- Dentists
- Dental Auxiliaries (defined as any non-dentist staff employed by the dentist to assist in the operation of the practice)

Mental Health

Psychiatrists*

*For all Mental Health designations, the providers counted in the Population-to-Provider ratio may differ from one state to another, at the discretion of the state's Primary Care Office. The ratio may consist of Psychiatrists only, Core Mental Health providers only, or both Psychiatrists and Core Mental Health providers. The Core Mental Health classification includes psychiatrists, clinical psychologists, clinical social workers, psychiatric nurse specialists, and marriage and family therapists. The SOPC-RH includes only Psychiatrists in the determination of Mental Health HPSAs.

As a grantee of the HRSA Primary Care Office cooperative agreement, the SOPC-RH is tasked with proactively seeking HPSA and MUA/P data for shortage designations for geographic areas and populations experiencing barriers to care, including access to providers. The office is responsible for the collection of professional FTE data used in determining the population-to-professional ratios. The process of surveying health care professionals is accomplished through a contract with Fort Hays State University. Providers are asked to self-report the average number of hours per week spent providing direct patient care, which is defined as providing primary health services in an outpatient or ambulatory setting. Direct patient care does not include time spent teaching, conducting research, completing administrative duties, or serving in an advisory or supervisory role. All other data used in HPSA scoring is obtained through U.S. census data and other national sources.

Maternity Care Target Area (MCTA)

A MCTA serves as a supplementary component within the broader framework of the Primary Care (PC) HPSA designation. It aims to specifically address maternity care services within areas that are designated as a primary care shortage area. Eligibility for a MCTA score is contingent upon the existence of an established Primary Care HPSA designation.

Background and Overview

The final MCTA Federal Register Notice was published in May 2022. HRSA added MCTA scores to existing PC geographic, population and Auto-HPSAs with a 'Designated' status in November 2022.

Federal Medically Underserved Areas and Medically Underserved Populations

The Medically Underserved Area (MUA) criteria were developed by the federal government to support the federal health maintenance organization (HMO) grant program, which targets areas for community health centers (CHC) and rural health clinics (RHC). County or partial county areas are eligible for designation as an MUA. Discrete populations, such as a prison population or Medicaid recipients within a county, are eligible for designation as a Medically Underserved Population (MUP). Areas or populations are scored on the following criteria:

Percentage of population below 100 % FPL

Percentage of population over 65 years old

Infant mortality rate

Ratio of primary care physicians per 1,000 population

Facility and Auto-Facility HPSAs

Federally qualified health centers (FQHCs) and rural health clinics (RHCs) may be granted an Auto-Facility HPSA designation. An FQHC look-alike (LAL) has been identified by HRSA as meeting the definition of an FQHC but does not receive grant funding. To be certified as an FQHC, an entity must be a HRSA Health Center Program grantee; these include:



Community health centers



Migrant health centers



Health Care for the Homeless health centers



Housing primary care centers



Outpatient health facilities operated by a tribe, tribal organization or an urban Indian organization

Governor-Designated Medically Underserved Areas


The Governor's designation of MUA is used only for RHC eligibility. If a county's population exceeds 2,695 persons per adjusted count of primary care physicians or 37.1 physicians per 100,000 population, it is considered an underserved area. Any time a HPSA or state MUA designation is needed for RHC eligibility, and a county believes its status has changed, the county may ask the SOPC-RH to reevaluate the county MUA designation. When identifying a reasonable minimum number for practice viability in frontier areas, Kansas considers the service area to be underserved if there are fewer than two primary care professionals available. A list of counties that meet the criteria for designation of a Governor's-Designated MUA is provided on the following page.

An RHC is in a rural area which must have a Primary Care HPSA or an MUA, designated or updated within the last four years and is designed to increase the availability of health care services in rural areas. Participation as an RHC allows Medicare and Medicaid reimbursement for health care services provided by physician assistants and nurse practitioners. RHC services covered by Medicare and Medicaid are paid on a cost basis, providing an incentive for clinics that use nurse practitioners or physician assistants at least half-time. There are 182 RHCs in 85 counties as illustrated in the map below.









Primary Care HPSA Designation Status by County







Workforce Recruitment and Retention Programs Kansas State Conrad 30 J-1 Visa Waiver Program

Kansas participates in the State Conrad 30 J-1 Visa Waiver Program, which assists in the recruitment of physicians to practice in communities that lack adequate access to primary health care. Section 214-(1) of the Federal Immigration and Nationality Act [8 USC Section 1184(I)] allows each state to annually recommend up to 30 international medical graduates to be granted a waiver of the J-1 visa two-year home-country residency requirement, in return for practicing medicine full-time for a minimum of three years in a medically underserved area. This allows Kansas to have 90 physicians working in the state to provide care in our underserved areas. Selection of these physicians is competitive and is based on HPSA score, primary care (prioritized) versus specialty care, and rural (prioritized) versus urban location, percentage of Medicaid and other low-income patients served, need of facility, number of recent waivers approved by the health facility, and number of recent waivers approved for the geographic location. In 2022, 28 physicians were recommended for the program.

Kansas State Loan Repayment Program

The State Loan Repayment Program (SLRP) provides loan repayment assistance for qualifying educational loans to health care professionals working at approved practice sites within a HPSA. The SLRP program provides loan repayment assistance to eligible professionals in areas not covered by the National Health Service Corps Loan Repayment Programs (NHSC LRP). After the initial two-year SLRP service commitment, continuation contracts may be granted in one-year increments for up to three additional years of service.

The health care professional must commit to providing direct patient care services at an eligible practice site and must be licensed to practice in Kansas in one of the approved disciplines listed in Table 6. Unlike the NHSC LRP, the SLRP has a year-round application cycle, making the possibility of loan repayment a reality for even more health care professionals.



National Health Service Corps and Nurse Corps Loan Repayment Programs

The National Health Service Corps (NHSC), part of the Health Resources and Services Administration (HRSA), offers several different options for scholarships and financial support to providers and students pursuing a career in primary care, in exchange for a commitment to work in an HPSA or MUA for at least two years. Additionally, the Nurse Corps programs help to build healthier communities in urban, rural and frontier areas by supporting nurses, nurse faculty, and nursing students committed to working in communities with inadequate access to care. In 2022, the NHSC had a total of 227 participants at 92 practice sites in Kansas.

Nurse Corps Loan Repayment Program

The Nurse Corps Loan Repayment Program (NC) LRP is available to provide loan repayment assistance to registered nurses (RNs), including advanced practice registered nurses (APRNs), in return for a commitment to work at eligible health care facilities with a critical shortage of nurses or serve as nurse faculty in eligible schools of nursing. In 2022, the NC LRP had 21 participants at 17 practice sites in Kansas.

Nurse Corps Scholarship Program

The Nurse Corps Scholarship Program is available to eligible nursing students. If accepted, HRSA pays the tuition, fees, and other educational costs. In return, the participant works at a Critical Shortage Facility upon graduation.

NHSC Loan Repayment Program

The NHSC Loan Repayment Program (NHSC LRP) offers aid to primary care medical, dental, and mental and behavioral health care professionals. The LRP offers levels of student loan repayment awards up to \$50,000 in exchange for a health professional's two-year full-time, or four-year part-time, service commitment in a federally designated HPSA.

NHSC Rural Community Loan Repayment Program

The Rural Community (RC) LRP provides up to \$100,000 to qualified health professionals working to combat the opioid epidemic in rural communities.

NHSC Scholarship Program

The NHSC Scholarship Program (SP) awards scholarships to students pursuing a career in primary health care professions. Scholars are eligible to receive funding for their education in exchange for practicing in rural, urban, and tribal communities with limited access to care upon graduation and licensure.

NHSC Students-to-Service Loan Repayment Program

The Students to Service (S2S) LRP provides up to \$120,000 to students pursuing degrees in primary care who are in their final year of medical, dental, or nursing school. In return, awardees provide at least three years of service at an NHSC-approved site in a designated HPSA.

NHSC Substance Use Disorder Workforce Loan Repayment Program

In response to the nation's growing opioid crisis, the NHSC has added the Substance Use Disorder (SUD) Workforce LRP. An award of up to \$75,000 is offered in exchange for a three-year commitment by substance abuse professionals working in underserved areas to expand access to SUD treatment and prevent overdose deaths.

For all loan repayment programs, the NHSC gives priority funding to current or former NHSC scholars who have completed their service obligation and have eligible student loans. In addition, applicants in each HPSA discipline receive a ranking for having a disadvantaged background, then by demonstrating characteristics that show they'll likely remain in a HPSA – such as completing a Primary Care Training and Enhancement (PCTE) Fellowship.








NHSC Mental Health Participants per County

Kansas Recruitment and Retention Center


The Kansas Recruitment and Retention Center (KRRC), which is located within the Rural Health Education and Services Department at KU Medical Center, partners with hospitals, private physician practices, community health centers and other organizations to bolster the health care workforce in communities across the state. KRRC services are designed to assist Kansas communities in recruiting and retaining physicians, dentists, pharmacists, physician assistants, APRNs, nurses, dental hygienists, allied health professionals and behavioral health professionals. KRRC Career Services supports all health care professionals throughout the job search process and assists in finding the right practice opportunity. Funding for the KRRC is provided, in part, by the SOPC-RH.

Since 2004, the KRRC has assisted more than 355 health care professionals with finding a practice opportunity in 86 Kansas communities with 135 different Kansas health care organizations.

These include:

- 209 Physicians
- 76 Advanced-Practice providers
- 30 Behavioral Health Professionals
- 17 Nurses
- 16 Dentists and Dental Hygienists
- Nine Allied Health Providers

Rural Hospital Programs

Medicare Rural Hospital Flexibility (Flex) Program

The Medicare Rural Hospital Flexibility (Flex) program is a federal initiative aimed at supporting rural health care access. It provides funding and regulatory flexibility to Critical Access Hospitals (CAHs) to improve health care services in underserved rural areas. Flex helps CAHs enhance their quality of care, financial stability, and community outreach to ensure rural residents have access to essential health care services.

Small Hospital Improvement Program

The Small Hospital Improvement Program (SHIP) is a federally supported program to support small rural hospitals' activities related to quality improvement and investments towards meaningful use of health information technology. In 2022, 91 hospitals participated and received more than \$1,036,000 to assist with improvement projects.

Both Flex and SHIP are managed by the SOPC-RH in partnership with Healthworks to provide technical assistance and outreach for these programs. The SHIP and Flex programs are funded by the Federal Office of Rural Health Policy (FORHP) within HRSA.

Rural Hospital Innovation Grant

The Rural Hospital Innovation Grant (RHIG) was established by the Kansas Legislature in May 2021 to strengthen and improve health care systems and increase access to health care services in eligible Kansas counties and help residents achieve and maintain their optimal health. Funds are to be used at a hospital within the county for transitional assistance related to changing to a model more appropriate for the community the hospital serves. Any state funds awarded must be matched by an outside stakeholder at a 2:1 ratio.

Charitable Care Programs

Charitable Health Care Provider Program

The Kansas Charitable Health Care Provider Program (CHCP) allows indigent health care clinics and providers serving medically indigent individuals to receive coverage under the Kansas Tort Claims Act for liability purposes. When acting as a CHCP, the provider is considered an employee of the state. Any claims against a CHCP arising from the provision of gratuitous care to medically indigent individuals may be paid from the Kansas tort claims funds. Claims against CHCPs under the Kansas Tort Claims Act may not be considered by an insurance company in determining the rate charged for professional liability insurance for health care providers or in the determination to cancel any such policy. Per the Kansas Charitable Health Care Provider Statute 75-6101, the CHCP does not serve as or replace malpractice insurance. Participants in CHCP with specific questions about their professional liability should contact their attorney.


The Kansas Legislature allows for one hour of continuing education credit for every two hours of gratuitous service, for a maximum of 20 continuation education credits per licensure period.

There were 83 active charitable health care clinics in 2022 with a total of 2,909 active charitable health care providers enrolled in the program.

Community-Based Primary Care Clinic Program

The Community-Based Primary Care Clinic (CBPCC) program assists clinics in improving access to quality health care with an emphasis on community-based services and reducing health disparities for underserved populations. Grant funds are intended to make primary medical and dental care, prescription drugs, and preventive health care services accessible and affordable to underserved Kansas residents, including uninsured individuals and those enrolled in public insurance programs that are operated by the State of Kansas (KanCare) or the federal government with eligibility based on income. Over \$11 million in state general funds were awarded to 33 clinics across the state in 2022. Of the total funds awarded, over \$7 million was used for primary care services, over \$3 million for dental services, and nearly \$440,000 for prescription assistance.

Unused Medications Program and Repository

Through the Utilization of Unused Medications Act (KSA 65-1668 through 1675), the Kansas Repository collects, manages, and distributes hundreds of thousands of prescribed medications that would otherwise be destroyed, to FQHCs, indigent health care clinics and community mental health centers in the state. This allows uninsured Kansans access to medications they cannot afford. Administered by the Community Health Center of Southeast Kansas, the Unused Medications Repository provides donated medications free of charge to eligible clinics. Since 2011, over \$21 million worth of prescription medications have been donated to low-income and uninsured Kansans. In 2022, approximately 4,890 residents benefited from an estimated retail value of over \$781,434 in donated unused medications.

Health Care Facility Definitions

Community Mental Health Centers (CMHCs) In addition to providing the full range of outpatient clinical services, Kansas' 26 CMHCs provide comprehensive mental health rehabilitation services, such as psychosocial rehabilitation, community psychiatric support and treatment, peer support, case management, and attendant care.

Critical Access Hospitals (CAHs) are facilities designated by the federal Centers for Medicare and Medicaid Services (CMS). The designation is designed to reduce the financial vulnerability of rural hospitals and improve access to health care by keeping essential services in rural communities. To accomplish this goal, CAHs receive certain benefits, such as cost-based reimbursement for Medicare services. The Critical Access Hospital program is part of a larger federal initiative, the Medicare Rural Hospital Flexibility (FLEX) program.

Rural Emergency Hospital (REH) is a designation given to eligible rural hospitals by CMS. This designation is new to the State of Kansas and began on January 1, 2023. The REH designation is designed to maintain access to critical outpatient hospital services in communities that may not be able to support or sustain a CAH or small rural hospital. REHs are required to provide 24-hour emergency and observation services and can elect to furnish other outpatient services. Facilities designated as an REH will receive enhanced Medicare payments for certain outpatient services and additional monthly payments.

Federally Qualified Health Centers (FQHCs) are outpatient clinics that qualify for specific reimbursement systems under Medicare and Medicaid. Health Center Program Awardees receive funding from the HRSA Bureau of Primary Health Care under the Health Center Program, as authorized by Section 330 of the Public Health Service Act. Most awards provide support to contribute to serving an entire underserved community or service area, while others fund specific underserved populations as mandated in the Section 330 authorization, such as migratory and seasonal agricultural workers, persons experiencing or at risk for homelessness, and residents of public housing.

Federally Qualified Health Center (FQHC) Look-Alikes are health centers that have been designated by HRSA as meeting all the Health Center Program requirements but do not receive award funding under the Health Center Program.

Rural Health Clinics (RHCs) The Rural Health Clinic (RHC) program is intended to increase access to primary care services for patients in rural communities. RHCs can be public, nonprofit, or for-profit health care facilities. To receive certification, they must be located in rural, underserved areas. RHCs are required to use a team approach of physicians working with non-physician providers such as nurse practitioners (NP), physician assistants (PA), and certified nurse midwives (CNM) to provide services.

Safety Net Clinics (SNCs) are mission-focused and provide care to individuals regardless of their insurance status and ability to pay. Safety nets are a necessary 'last resort' for uninsured and underserved Americans and those vulnerable populations who cannot afford to seek care elsewhere.

Tribal & Urban Indian Health Centers Tribal Contract or Compact Health Centers (also called a 638 contract or compact) are operated by Tribes or Tribal organizations. They are operated under the Indian Self-Determination Act. Urban Indian Health Centers are designated FQHCs that that specialize in caring for American Indians and Alaska natives.

Local Health Departments A county health department is a government organization that protects and improves the health of people in a specific area. The department works with local partners to address specific health issues and reduce inequalities, considering both medical and social factors.

Veteran's Association (VA) Hospitals A VA hospital, run by the U.S. Department of Veterans Affairs, provides medical services for eligible veterans. These hospitals offer specialized care, including medical, surgical, and mental health services, catering to the specific needs of veterans who have served in the U.S. military.

Inspiration from the Community

Community Health Center of Southeast Kansas - Pittsburg, KS



CHC/SEK is a Federally Qualified Health Center (FQHC) providing medical, dental, behavioral health, pharmacy, and support services across southeast Kansas. CHC/SEK has been a longtime CBPCC grant recipient and takes part in loan repayment programs that encourage rural health recruitment and retention. On July 13, 2021, CHC/SEK President and CEO, Krista Postai, was recognized for her and her staff's immense efforts throughout the pandemic with the proclamation of "Krista Postai Day" in Pittsburg. She was recognized for her vision of what health care should be and her incredible leadership

that has helped build CHC/SEK into what it is today.

At a luncheon where the proclamation was read, Postai was quick to share the credit with the health center's more than 600 staff members who give their all to patients. Under Postai's leadership, CHC/SEK responded to the COVID-19 pandemic in a unified and coordinated response, serving its eight Kansas and Oklahoma counties of more than 70,000 patients. From the first indication of cases, Postai brought together her team to develop the infrastructure to be able to pivot their operations to respond to the evolving crisis. By using all ways possible, the health center has provided more than 85,500 COVID-19 tests.

"Krista's commitment to the well-being of the citizens in Southeast Kansas is evident every day at the clinics of (CHC/SEK)," Governor Laura Kelly said in a letter. "For her valuable contributions and unwavering efforts to improve the quality of health care in Southeast Kansas, I would like to personally extend my sincere gratitude for extraordinary service during this past year."

During these uncertain times, CHC/SEK continued to provide essential services. Through creativity and innovation, the health center expanded its telehealth services and flipped its care model to curbside service – seeing patients in its parking lots. When the vaccine became available, Postai deployed teams to go into communities and vaccinate anyone wanting the vaccine resulting in the distribution of more than 66,400 vaccines. The value she places on collaboration allowed CHC/SEK and the area's county health departments to maximize their resources and reach more Kansans.

Postai took care of her staff in a time of challenge, fear, and uncertainty. "I'm incredibly blessed to work with so many tremendous people, many of you people walked out on that ledge with me," she said. "All that made us stronger and better and tighter. It's been a wonderful and incredible experience."

Connie Rupp, the Patient Financial Counselor for Greeley County Health Services whose position is funded with the help of the SOPC-RH through the CBPCC grant, shared an amazing story highlighting the impact that she's able to have on her western Kansas community.

A retired couple that recently moved to the area had no monthly income or Medicare coverage in place. They were in desperate need of getting connected to local and government resources. Following a visit to the clinic, Connie was able to get both set up to receive their Social Security retirement along with Social Security Disability Insurance (SSDI) and Social Security Income (SSI) benefits. They are now both approved for KanCare health insurance and began the process of applying for Medicare.

In addition to the financial and medical support that Connie was able to assist the couple with, she was also able to help them receive food from the local food pantry, the commodity distribution food box, Kansas Food Bank's Senior Citizens Bob Boxes, and has applied for additional food security services on their behalf through The Harvest America Corporation.

Before receiving assistance from Greeley County Health Services, the couple was living on nothing but rice and beans every day. Connie truly changed their lives in an incredibly impactful way!

Mercy and Truth Medical Missions - Shawnee & Kansas City, KS



It was a sunny autumn Saturday for Mercy and Truth Medical Missions' BOO TO THE FLU event on October 30, 2021.

Their 4th annual flu shot event had cars lining up at both clinics several hours in advance. Not only were 355 flu shots given, but turkeys, hoodies, and food boxes were given to all in the contactless, drive-through line.

This year's theme for BOO TO THE FLU was "Win With Us." Totes, hoodies, and shirts were in Kansas City Chiefs' colors of red and yellow. An officially

licensed Chiefs T-shirt was given out to anyone who also received a COVID-19 vaccine (55 vaccinations were given out that day).

Mercy and Truth operate two safety-net clinics in Kansas; one is located in Wyandotte County, the 8th poorest county in Kansas, and the other clinic in Johnson County. Serving the uninsured and underserved in these counties has made staff realize that many patients have no sick leave, making flu shots critically important for Mercy and Truth's population as a great preventative strategy.

The Kansas Department of Health and Environment (KDHE) graciously donated all the flu shots for BOO TO THE FLU. "We are grateful for the partnership that we have with KDHE", said Executive Director Geofrey Kigenyi.

Not only did many individuals receive free flu shots, thirteen television spots ran on local news stations. It is estimated that over 400,000 people viewed these TV spots, increasing awareness of Mercy and Truth and the services that safety net clinics provide.

Enrolling in the Master of Public Health program was made possible by the COVID-19 pandemic, which allowed KU Wichita to offer online courses. Living a considerable distance from Wichita, this change removed a significant barrier for Tori. She's now on track to graduate in 2023.

Her dedication to marginalized populations extends beyond her chiropractic practice. Tori's unwavering belief in health equity for smaller communities drives her to serve on the board of Goodland Regional Medical Center. She collaborates with organizations to improve health care outcomes for underserved populations.

Tori Gleason's story embodies resilience and compassion, epitomizing the pursuit of health equity for all. Her tireless advocacy continues to inspire those around her. In a world where change often seems daunting, Tori reminds us that one person's dedication can ignite hope and drive progress, making our communities more inclusive and just.

Inspiration from the Community

Mercy and Truth Medical Missions - Kansas City, KS

Mercy and Truth Medical Missions (locations in Kansas City, KS and Shawnee, KS) held their first free Saturday clinic on May 22, 2021 at their KCK inner-city clinic. Plans were in place for 25 free visits, no appointment was necessary; just see a doctor. Partnering with volunteers and medical providers from Advent Health, the doors opened, and slots were filled.

Mercy and Truth held monthly clinics from June through October. Some people who came had not seen a doctor in years. One patient was sent to the emergency room after having an EKG and complaining of chest pains. Entire families, some as large as six members, came to the free clinic for care. Personal hygiene needs were addressed, and a community health worker volunteered her time to help those who needed to receive further social services.

"There is a definite need for free Saturday health care clinics. We helped people who otherwise might not have had access to medical care, and they learned of other resources that the community health worker provided," said Anne Rauth, Director of Marketing, Development and Community Outreach.

Without support from the SOPC-RH and partners like Advent Health, these clinics would not be able to continue.
